That's a sign you're ready for a structure built around your style, not the other way around.

SIGN #2: You Want to Offer More, But Your Firm Says “No”

Maybe you want better planning tools, more investment flexibility, a newer technology stack, or simply a client-first approach that isn't overshadowed by quotas or product pushes.

But instead you hear:

- “Not approved.”
- “Not available.”
- “Not on our platform.”

Your vision has outpaced their menu. That's a sign.

SIGN #3: Growth Has Stalled and You Can't Explain Why

When you feel stuck despite doing everything right, prospecting, reviewing, planning, communicating, the issue often isn't you. It's the ceiling above you.

Advisors who move to independence usually report their fastest 12-24 months of growth right after the transition. Why? The space around them finally matches their ambition.

SIGN #4: The Firm's Direction Feels... Off

Maybe it's new leadership.

Or new quotas.

Or a new platform.

Or a shift toward corporate goals that don't feel client-first.

When the firm's path diverges from your values, you feel it in your gut long before you see it on paper.



The 60-Second Gut Check

- Am I proud of the experience my clients get?
- Am I energized or drained after a day of work?
- Am I growing or just producing?
- Would I join my current firm if I were choosing today?
- Do I feel free or managed?

SIGN #5: You're Doing Too Much That Isn't Advisor Work

You know this one:

More admin. More paperwork. More ticket chases. More tech frustrations. More busywork.

Less client time. Less strategic time. Less meaningful work.

When your role stops looking like the job you signed up for, you've definitely outgrown the structure around you.

SIGN #6: You Find Yourself Wondering What You're Missing

It's subtle at first.

You're curious about what advisors outside your firm are doing.

You read more industry articles.

You wonder about independence.

You look at your long-term goals and feel... misaligned.

That curiosity is your professional intuition nudging you forward.
